In the recall period...

Have you pushed, grabbed, or shoved your partner?

Have you twisted your partner's arm?

Has your partner punched, choked, strangled, kicked, or bitten you?

Have you choked or strangled your partner?

Have you slapped your partner?

Have you shaken your partner?

Has your partner thrown an object at you or tried to hit you with an object?

Have you had broken bones from being hit by your partner?

Has your partner had broken bones from being hit by you?

Have you needed to see a doctor or go to an emergency room because of a fight with your partner?

Did you do any of these things you mentioned above to (primary gf/bf as defined earlier)?

Did (primary gf/bf as defined earlier) do any of them to you? (Y/N)

Has your partner tried to stop you from working or studying?

Have you told your partner that he or she could not work or study?

Has your partner tried to stop you from having contact with family, friends or co-workers?

Have you tried to stop your partner from seeing/talking to family or friends?

Have you restricted your partner's use of the car or telephone?

Has your partner become angry (e.g., yelled, gotten real upset) when you disagreed with his or her point of view?

Have you become angry (e.g., yelled, gotten real upset) when your partner disagreed with your point of view?

Has your partner damaged, destroyed, hid or thrown out any of your clothes or possessions?

Have you damaged or hid or thrown out any of your partner's clothes or possessions?

Has your partner locked you out of the house?

Have you locked your partner out of the house?

Has your partner insulted or shamed you in front of others?

Have you insulted or shamed your partner in front of others?

Has your partner damaged or destroyed any other property when angry with you?

Have you damaged or destroyed property other than your partner possessions when angry at him or her?

Has your partner threatened to leave you?

Have you threatened to leave your partner?

Has your partner called you stupid, fat or ugly?

Have you called your partner stupid, fat or ugly?

Did you do any of these things you mentioned above to (primary gf/bf as defined earlier)?

Did (primary gf/bf as defined earlier) do any of them to you? (Y/N)

Has your partner used physical force or threats of force to make you have sex when you didn't want to?

Have you used physical force to make your partner have sex when he/she didn't want to?

Have you used threats to make your partner have sex when he/she didn't want to?

Did you do any of these things you mentioned above to (primary gf/bf as defined earlier)?

Did (primary gf/bf as defined earlier) do any of them to you? (Y/N)
